Fair Housing Act Protections from Sex Discrimination Include Sexual Orientation and Gender Identity. Direct Emergency Financial Assistance, Public Health Management Corporation (Ryan White Funds)

The Direct Emergency Financial Assistance (DEFA) Program is administered through the Public Health Management Corporation (PHMC). DEFA is an emergency financial resource for people living with HIV/AIDS faced with an emergency that demands immediate attention. The fund helps with imminent homelessness, access to medications, and other resources.

Pennsylvania Homeowners Assistance Fund www.PHFA.org

Provides funds for past due property taxes, reverse mortgage insurance premiums, homeowner association (HOA) fees, condominium fees, or common charges that put the owner of the property atrisk including mortgage foreclosures and displacement of homeownership. Maximum assistance falls under the maximum cap of \$30,000 or 24 months, \$5,000 for delinquent property taxes of up to 24 months and not prior to fiscal year 2020, \$3,000 for insurance premiums and \$5,000 for delinquent homeowner/ condominium fees.

Beaver County Home Improvement Program (HIP) https://beavercountyhousing.org/home-improvement-program/

Beaver County through its Community Development Block Grant funds for the Home Improvement Program (HIP). The objectives of HIP are to stabilize the housing stock by providing rehabilitation assistance to eligible county residents. The Beaver County Home Improvement Program was created to provide financial assistance to eligible home owner/occupants. This financial assistance is offered in the form of a zero percent interest loan/deferred payment grant. The amount of assistance varies based upon household income and is to be used to return the housing unit to a code compliant condition. Due to the growing demand for participation in HIP, recipients of the 0% Interest Loan/Deferred Payment Grant will be determined by a lottery drawing at the beginning of September. Pre-applications will be available starting each August. The applications must be completed and submitted to the HACBHRD for inclusion. Armstrong County Community Action Agency provides state funded weatherization free to qualified individuals regardless of whether you rent or own. Depending on need, a home can have its air infiltration measured; attic insulated and ventilate; walls and floors insulated; pipes wrapped; incidental repairs completed, and the electric baseload measured.
